## Water Bill Payment Options

- A **check** made out to East Dillon Water District and mailed to PO Box 3428, Dillon, CO 80435
- Sign up for **ACH** (direct payment). The billing amount will be deducted from your bank account approximately 20 days following the billing date. The sign up form is available at [www.eastdillon.com](http://www.eastdillon.com).
- **Credit Card** payments. Credit card payments can be made using the State of Colorado payment system. Access the online payment system through [www.eastdillon.com](http://www.eastdillon.com). The State system has a nominal fee for a credit card payment. The fee amount will be indicated to you as you are making the payment prior to the final payment authorization. You will need your account number, account name, property address and billing amount to process the credit card payment.
- **Electronic check** payments. You can initiate a direct payment from your checking account using the State of Colorado payment system. Access the online payment system through [www.eastdillon.com](http://www.eastdillon.com). A choice between a credit card payment and a discounted payment from your bank account will be provided. The State fee is \$1. You will need your account number, account name, property address and billing amount to process the electronic check payment.
- Payments can be made during regular business hours at the Administration office located at 114 Village Pl, Dillon Tech Center, Suite 304, Dillon, Colorado. **Cash** is accepted, but we are unable to make change.
- Payment initiated electronically with **your banking** online system. Payments you originate from your bank come to us by check and they are posted to your account as received through the US Mail.

## IRRIGATION USAGE

This billing for the period April 1<sup>st</sup> through June 30<sup>th</sup> includes irrigation usage for some customers. Historically, water usage for irrigation can be substantially higher than usage inside the home. Customers are reminded that because of the late and wet spring, the irrigation period was limited. The next billing, for the period July 1<sup>st</sup> through September 30<sup>th</sup> generally has a significantly longer irrigation period that could reflect on the amount billed for water. We can provide a report of daily usage to you via email.

Landscaping can have a beautiful summer appearance with sensible watering. Turf grass should not be watered daily as too much water encourages shallow roots. Please do not water in the middle of the day when heat and wind can evaporate the water being applied before it can be used by the plants. Unintentional high water usage can occur from leaks in irrigation systems.

## VOLUNTARY WATER RESTRICTIONS

The snow pack from the winter has been beneficial to the available water supply. However, the District encourages all users to conserve water. The voluntary water restrictions for the East Dillon Water District are:

- ❑ Outside usage is not allowed on Mondays and Thursdays.
- ❑ Outside usage is not allowed between the hours of 10 AM and 6 PM.
- ❑ Hand watering, using either a watering can or a hose with a shut off nozzle is **ALLOWED** at anytime (no restrictions as to days or time).
- ❑ Outside usage using drip irrigation systems is not restricted.

The voluntary restrictions are for outside usage and are in effect until October 1<sup>st</sup>. The District monitors water levels in our aquifer and customer usage patterns. Should weather patterns, usage levels or water source problems warrant, the District can impose mandatory water restrictions.
