## Water Bill Payment Options

- A **check** made out to East Dillon Water District and mailed to PO Box 4526, Dillon, CO 80435
- Sign up for **ACH** (direct payment). The billing amount will be deducted from your bank account approximately 20 days following the billing date. The sign up form is available at [www.eastdillon.com](http://www.eastdillon.com).
- **Credit Card** payments. Credit card payments can be made using the State of Colorado payment system. Access the online payment system through [www.eastdillon.com](http://www.eastdillon.com). The State system has a nominal fee for a credit card payment. The fee amount will be indicated to you as you are making the payment prior to the final payment authorization. You will need your account number, account name, property address and billing amount to process the credit card payment.
- **Electronic check** payments. You can initiate a direct payment from your checking account using the State of Colorado payment system. Access the online payment system through [www.eastdillon.com](http://www.eastdillon.com). A choice between a credit card payment and a discounted payment from your bank account will be provided. The State fee is \$1. You will need your account number, account name, property address and billing amount to process the electronic check payment.
- Payment initiated electronically with **your banking** online system. Payments you originate from your bank come to us by check and they are posted to your account as received through the US Mail.

## 2015 WATER RATES

The East Dillon Water District bills quarterly and in arrears. This billing is for the 1<sup>st</sup> quarter of 2015.

The 2015 base rate increased from \$38 to \$39 per quarter. The rate schedule by water usage level will increase per the chart below. An average user in East Dillon has a 2.6% rate increase of \$2.15 per quarter. The rates are based on covering operating costs and to allow sufficient reserves for major infrastructure repairs and replacement.

### 2015 Quarterly Water Rates

Base rate \$ 39

#### Usage (per 1,000 gallons)

0-23,000 gallons	\$ 1.95
23,001-50,000 gallons	\$ 5.45
Over 50,000 gallons	\$10.90

The base rate in Summerwood above the booster pump station is \$68.

Tap Fee (new construction) \$ 9,500 per unit.

## VOLUNTARY WATER RESTRICTIONS

The District encourages all users to conserve water. The voluntary water restrictions for the East Dillon Water District begin May 1<sup>st</sup>. The restrictions are:

- ❑ Outside usage is not allowed on Mondays and Thursdays.
- ❑ Outside usage is not allowed between the hours of 10 AM and 6 PM.
- ❑ Hand watering, using either a watering can or a hose with a shut off nozzle is ALLOWED at anytime (no restrictions as to days or time).
- ❑ Outside usage using drip irrigation systems is not restricted.

The voluntary restrictions are for outside usage and are in effect until October 1<sup>st</sup>. The District monitors water levels in our aquifer and customer usage patterns. Should weather patterns, usage levels or water source problems warrant, the District can impose mandatory water restrictions.
